UNPA Digest Reader Survey, Fall 2016

- Survey sent via email to 600+ UNPA member company affiliates
- Three email outreaches
- 12 questions, some with multiple choice answers
- Seventy-three responses (11+%)



Amount of time spent reading the Digest

- 49% spend 3-5 minutes
- 30% spend 5-10 minutes
- 10% spend more than 10 minutes
- 11% go through it in 1-2 minutes



Frequency reading the Digest

- 59% read it every week
- 36% read it "regularly"
- 5% read it "occasionally"

- 60% click on the links "occasionally"
- 37% do so "regularly"
- 3% "don't do it very often"
- 1 respondent simply scrolls through the email
